### AREAS OF ACTIVITY

The Group is active in a diversified set of business sectors, such as construction, real estate and property development, golf courses and marinas, tourism and travel, hotels, entertainment, restaurants, the importation and trade of raw materials, and renewable energy.

The company has expanded its activities to the organization of events and conferences at the Lanitis Carob Mill Complex. It also offers catering services.

### LANITIS ENERGY LTD

The company provides holistic services related to trade, construction, generation, conservation and consultancy in the energy sector and, in particular, renewable energy sources (RES). Specialised products and services are provided through a number of subsid-



aries and associated companies (**Lanitis Electrics, Conercon Energy Solutions and Lanitis Gas**) in the areas of electrical systems, photovoltaics, solar power and solar heaters, liquid gas distribution, energy conservation and RES in general.

#### **LANITIS ARISTOPHANOUS LTD**

It is a leader in the markets for timber and its by-products, specialised building materials, sanitary ware, ceramic tiles and parquet floors.

#### **L.C.A DOMIKI LTD**

It is active in the local steel trading sector.

#### **AMATHUS PUBLIC LTD**

Established in 1943, it is listed on the Cyprus Stock Exchange. It has grown in recent years into a multidimensional organisation, covering a wide spectrum of activities in the tourism, travel and transport sectors. It also participates in the ownership and management of luxury hotels such as the Amathus Beach Hotel in Limassol, the Olympic Lagoon resort and the Amavi in Paphos.

The company was established with the goal of developing **Limassol Greens Golf Resort**, a new integrated golf and real estate project in the Fasouri area, on land owned by Lanitis Farm Ltd.

#### **LIMASSOL MARINA LTD**

The Lanitis Group participates in the biggest development project in recent years through Cybarco, which is a member of the construction consortium and in charge of the management of the project, with exclusive responsibility for property sales.

#### **EVAGORAS & KATHLEEN LANITIS FOUNDATION**

It is a non-profit organisation, founded in 2001 by Costas, Platon, Marios and Isabella, the children of Evagoras and Kathleen Lanitis. The Foundation was created to maintain the memory of Evagoras Lanitis and to continue his social contribution.
